The Belgian Chairmanship of the European Coast Guard Functions Forum (ECGFF) along with the Sea Fisheries Service of the Department of Agriculture and Fisheries of Belgium and the European Fisheries Control Agency (EFCA) are pleased to invite the relevant national experts to a workshop on:

"Use of evidence produced by innovative fisheries surveillance and inspection technologies"

from 2 to 4 May 2023 at Hotel Crowne Plaza Burg 10, 8000 Brugge, Belgium

In the framework of the European cooperation on coast guard functions, the three European Union Agencies, namely EFCA, the European Maritime Safety Agency (EMSA) and the European Border and Coast Guard Agency (Frontex) have been closely cooperating with the ECGFF in the implementation of activities identified as priorities by the Member States Chairing the Forum. The Belgian Chair of the ECGFF identified, together with EFCA, the theme of this workshop as an important one to be addressed for the Coast Guard and fisheries control community.

ECGFF – EFCA Workshop on the Use of evidence produced by innovative fisheries surveillance and inspection technologies

2 - 4 May 2023 -Bruges/Ostend, Belgium

Objective of this workshop:

Adequate fisheries surveillance and inspection capacities are key to ensuring compliance with relevant fisheries regulations and thus reaching the objectives of the Common Fisheries Policy (CFP). Proper enforcement requires establishing solid evidence in case of a potential non-compliance situation. In recent years, the use of innovative surveillance and inspection technologies, such as earth observation, remote sensing, vessel detection technologies and many others have led to a wide range of potential new ways of collecting evidence.

The objective of the workshop is to:

- Provide an overview of existing and emerging surveillance technologies and the type of evidence they could provide.
- Outline the legal requirements and challenges in view of using such evidence in enforcement and legal follow-up / prosecution procedures.
- Exchange views and collect feedback on the actual operational use, experiences, and challenges related to the use of evidence sourced from innovative technologies.
